



Group Structure



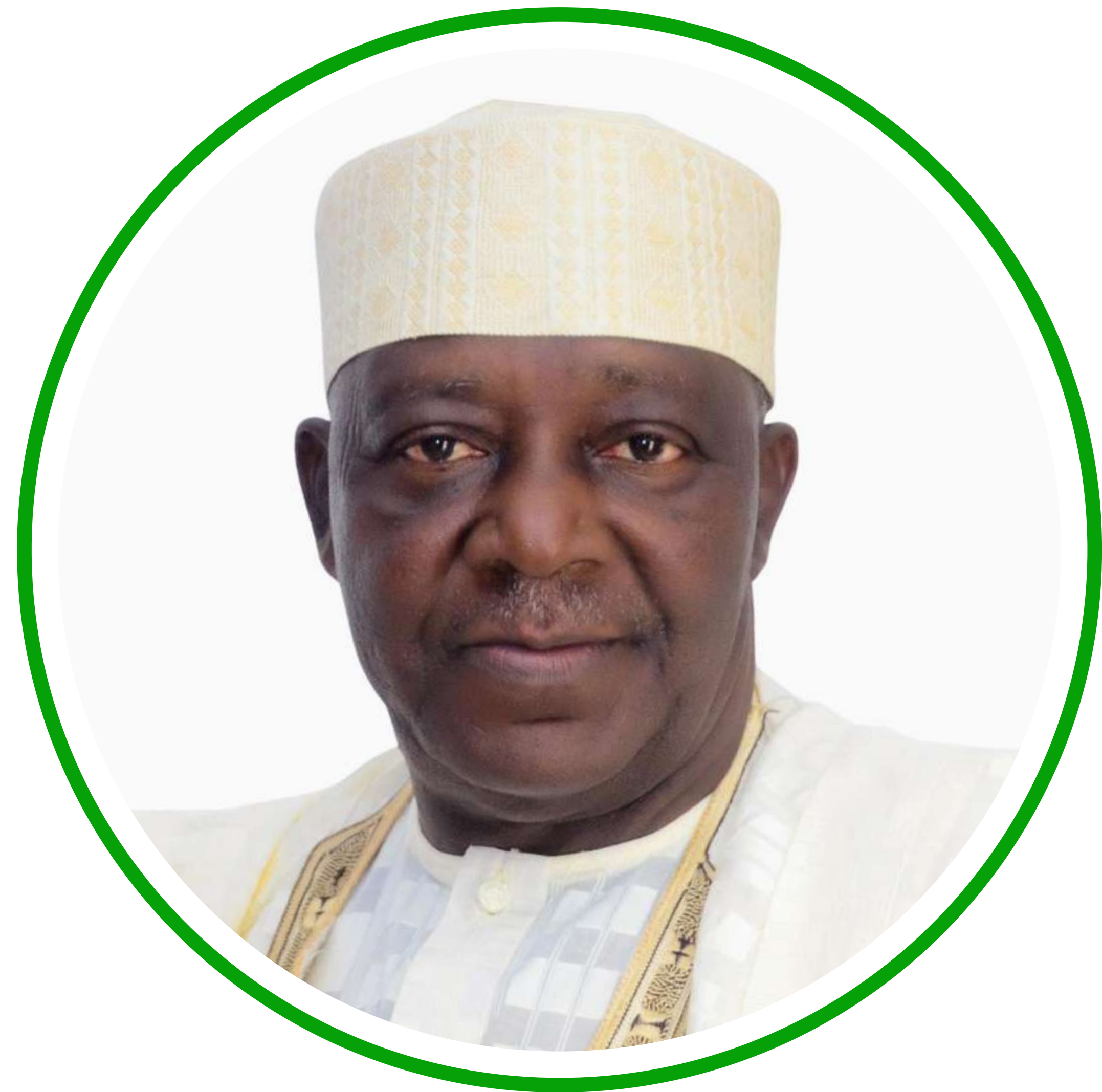
